

WHEREAS, the cost charged for various fees are in need of adjustment to ensure the City of El Reno and El Reno Municipal Authority will recover its expenses involved in providing certain services.

NOW, THEREFORE, be it resolved by the City Council of the City of El Reno, Oklahoma, and the Trustees for the El Reno Municipal Authority that the attached Exhibit A, with various services and fees set forth therein, are hereby established as fees to be charged by the City of El Reno and El Reno Municipal Authority for the specific services enumerated.

BE IT FURTHER resolved that the City Manager is authorized to charge any additional fees, as needed, to ensure El Reno will recover its expenses for services.


